Each website is regularly updated to ensure accuracy and clear, non-biased information on sexual and reproductive health. ASHA responds to requests from media sources looking for clarification, quotes and more.

Health Policy: ASHA's Washington office works to secure sound policy responses to sexual health issues including prevention, treatment, diagnostics and education through efforts with national organizations. ASHA's key relationships with colleague organizations, federal agencies and project related corporate efforts support the sexual health of individuals, families and communities in order to foster healthy behaviors and relationships.
