THE WEBSITES AND EDUCATIONAL CONFERENCES ARE THE PRIMARY MEANS OF EDUCATING PATIENTS, PARTNERS, PROFESSIONALS AND PARTNER ORGANIZATIONS THROUGHOUT THE UNITED STATES. EACH WEBSITE IS REGULARLY UPDATED TO ENSURE ACCURACY AND CLEAR, NON-BIASED INFORMATION ON SEXUAL AND REPRODUCTIVE HEALTH. ASHA PLANS AND CONDUCTS EDUCATIONAL CONFERENCES ANNUALLY WITH PARTNER ORGANIZATIONS. ASHA ALSO RESPONDS TO REQUESTS FROM MEDIA SOURCES LOOKING FOR CLARIFICATION, QUOTES AND MORE. ACTIVITIES PREVIOUSLY CATEGORIZED UNDER HEALTH POLICY ARE NOW REFLECTED WITHIN THE BROADER SCOPE OF CONSUMER COMMUNICATIONS/EDUCATION, ENSURING CONTINUITY OF THESE VITAL INITIATIVES WHILE LEVERAGING SYNERGIES BETWEEN THE TWO AREAS.
